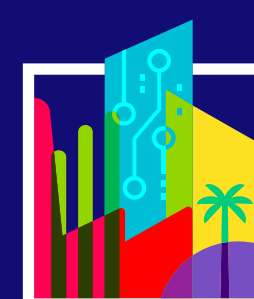

Terms & Conditions

By accepting the Terms & Conditions of the competition and subsequently submitting your videos, you have entered into an agreement with Destination Abu Dhabi. The organizers reserve the right to modify these Terms & Conditions without notice.

Usage Rights

By entering the competition, you grant the organizers a non-exclusive, irrevocable, royalty-free, worldwide, perpetual license (with a right to sub-license) to reproduce, enlarge, publish, edit or modify the competition entry or exhibit, on any media, the images for any purpose to further its aims and objectives. More specifically to use include but are not limited to the following:

At presentation events, including exhibiting videos within GCC Region on the organizers' social media channels and in the organizers' email communications.

In the press to publicize this video competition and the promotional activities.

In conjunction with the main sponsors to further promote this videography competition to selected Corporate Members for promotion and sponsorships.

The right to use your name and country of residence for the purpose of identifying you as the author of your entry and/or as a winner of the Competition.

The winners may be required to participate in promotional activity related to the Competition, and the winners shall participate in such activity at the organizers' reasonable request. The winners consent to the use by the organizers and its related companies, both before and after the closing date of the Competition for an unlimited time (in any medium, including still photographs and films, and on the internet, including any websites hosted by the organizers and its related companies) and in advertising, marketing or promotional material without additional compensation or prior notice and, in entering the Competition, all entrants consent to the same.

The organizers will make every reasonable effort to ensure that name credits are given to any videos published in any medium.

Data Protection

We will keep your details on our secure database to enable us to use your video (see usage rights) and send you information about the competition and other information.

Indemnity and Limitation of Liability

You agree to indemnify Destination Abu Dhabi and keep the organizers indemnified against any loss, damage, injury, cost, or expense suffered by the organizers as a result of your entry into the competition, including (but not limited to) any claim of infringement of intellectual property rights made by any third party.

You also hereby waive all your moral rights in your entry. Notwithstanding the afore-going waiver, in order to use entries as intended and advised in these Terms and Conditions, (i) The organizers may need to modify entries, including but not limited to resizing, cropping or color adjustment as necessary, provided that the organizers shall endeavor in undertaking such modifications to maintain the integrity of your entry as initially created; and (ii) the organizers shall reasonably provide a video credit for all entries.

To the maximum extent permitted by law, the organizers exclude its liability for any loss, damage, injury, cost, or expense suffered by you, whether directly or indirectly and howsoever caused, in connection with the competition and use of any prize. Nothing in these terms and conditions shall exclude the organizers' liability for death or personal injury arising from the organizers' own negligence or any other liability that cannot be excluded as a matter of law.
